PROPOSITION NO. 1
CREATION OF REGIONAL FIRE PROTECTION SERVICE
AUTHORITY

The Boards of Fire Commissioners of Snohomish County Fire Protection District Nos. 14 and 18 passed Joint Resolution No. 31407 (Revised) concerning the creation of a regional fire protection service authority. This proposition would create the North County Regional Fire Authority effective January 1, 2008, having boundaries coextensive with Fire Protection District Nos. 14 and 18 and approve the regional fire protection service authority plan (which provides for existing fire district property tax levies to be used to fund the new fire authority) all as provided in chapter 52.26 RCW and Joint Resolution 31407 (Revised). HOSPITAL DISTRICT

PUBLIC HOSPITAL DISTRICT NO. 3
PROPOSITION NO. 1
BONDS TO EXPAND AND MODERNIZE
HOSPITAL FACILITIES

The Board of Commissioners of Public Hospital District No. 3 adopted Resolution No. 361 concerning a proposition to finance improvements to Cascade Valley Hospital. This proposition would authorize the District to improve and expand the hospital's emergency room to relieve overcrowding, add state-of-the-art laboratory and imaging equipment for patient diagnosis, modernize its primary and specialty medical care facilities and make other improvements; issue up to \$45,000,000 of general obligation bonds maturing within twenty-five years (25) to pay for such improvements; and levy annual excess property taxes to pay and retire the bonds, all as provided in Resolution No. 361.
