### PETITION TO FORM MOSQUITO CONTROL DISTRICT (RCW 17.28.020)

TO: THE HONORABLE CHELAN COUNTY COMMISSIONERS  
THE COUNTY OF CHELAN, STATE OF WASHINGTON

We, the undersigned, being registered voters resident in the territory legally described below, and equal in number to ten percent (10%) or more of the votes cast for the office of governor at the last gubernatorial election, hereby petition and request that the real property boundaries described below be organized as a mosquito control district in accordance with RCW Chapter 17.28. Petitioners further state as follows:

1. The boundaries of the area proposed to be organized as a mosquito control district are legally described on Exhibit "A".
2. The number of registered voters in the boundaries legally described on Exhibit "A" cast votes for the office of governor in the last gubernatorial election is 2,214.
3. The City of Leavenworth, Washington adopted **Resolution No. 4-2002**, passed by the City Council and approved by the Mayor at an open public meeting of the City of Leavenworth on March 26, 2002, in which the City of Leavenworth formally requested that it be included in the formation of the mosquito control district in accordance with RCW 17.28.030.
4. Petitioners request, upon certification by the Chelan County Auditor that this petition contains sufficient valid signatures as provided by RCW 17.28.030, that the Board of Chelan County Commissioners cause the text of the petition to be published and that further action be taken thereon all in accordance with RCW Chapter 17.28.

The petitioners have read the above or attached test and petition and consent to the filing of other pages hereof to be considered as part of this petition.
