

RESOLUTION NO-

Re: Special Election for Formation of Chelan County Mosquito Control District #2.

WHEREAS, the Board of County Commissioners received a petition to form the Chelan County Mosquito Control District #2 in accordance with Chapter 17.28 of the Revised Code of Washington; and

WHEREAS, on August 13, 2002, the Chelan County Auditor duly certified said petition indicating sufficiency; and

WHEREAS, in accordance with Chapter 17.28 RCW, a public hearing was conducted on September 9, 2002 to consider said petition; and

WHEREAS, at said public hearing the Board of County Commissioners considered the testimony offered by the public regarding the establishment of said district and the proposed boundary lines therefore; and

WHEREAS, at said public hearing the testimony offered generally consisted of favorable comments for formation and that with integrated pest control the environment would be protected; and

WHEREAS, the Board of County Commissioners considered whether the public necessity or welfare of the proposed territory and of its inhabitants required the formation of the district and considered whether the petition complied with the provisions of Chapter 17.28 RCW; and

WHEREAS, the Board of County Commissioners further considered the finalization of the boundaries of said proposed district,

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Chelan County Commissioners finds that the official title of the proposed district shall be the "Chelan County Mosquito Control District #2" and that the following legal description shall establish the definite and final boundary lines of the proposed Chelan County Mosquito Control District #2:

Portions of Sections 1, 2, 11, 12, 13, 14, 23, and 24 of Township 24 N, Range 17 E and portions of Section 6 and 7 of Township 24 N, Range 18 E. W. M., Chelan County, Washington describes as follows: Beginning at the center quarter corner of Section 23 Township 24 N Range 17 E thence West along the South line of the Southeast quarter of the Northwest quarter of the said Section 23 to the Southwest corner of the said subdivision thence North along the West line of the East half of the Northwest quarter of Section 23 to the Northwest corner of the said subdivision thence East along the North line of the said East half of the Northwest quarter of Section 23 to the North quarter corner of the said Section 23 thence North along the West line of the East half of Section 14 Township 24 N Range 17 E approximately 3200 feet to the Northwest corner of that Parcel recorded Chelan County Auditor's office Book 909, page 1318, own by Barron whose current parcel number is 24 17 14 130 200 thence along the North line of the said recorded parcel Easterly and on Easterly extension of the said North line to the East bank of the Wenatchee River and the point on the ordinary high water line of the Wenatchee River thence along the ordinary high water line on the East bank of the Wenatchee River Northerly and Northwesterly to the West line of the Southeast quarter of Section 11 Township 24 N Range 17 E thence North along the said West line to the North right of way line of State Highway 2. intersection of the said West right of way line with the West right of way line of Icicle Ditch as shown on the said Plat line on the Southeast edge of Lot 10 of Block 3 of the said Plat thence South 31° 56' West 259.7 feet to the Southeast corner of Lot 11 of the said Block 3 of the said Plat thence North 89° 41" West 429.4 feet to the Easterly right of way line of the county road as shown on the said Plat East Leavenworth also as shown on the Plat of Darling's Addition to Leavenworth thence Southerly, Southwesterly, Westerly and Southerly along the East right of way line of the said county road as shown on the Plat of Darling Land Company First Addition Leavenworth to the Northwest corner of that parcel record Chelan County Auditor's office Book 852 page 161 thence Easterly along the North line of the said parcel 450 feet to the Northeast corner of the said parcel thence South along the East line of the said parcel and the East line of Block 4 of the Plat of Darling Land Company First Addition to Leavenworth to the North line of Lot 2 of Short Plat 1794 thence Easterly along the said North line and North line of Lot 3 of the said Short Plat 1794 to the Northeast corner of the said Lot 3 thence South along the East line of the said Lot 3 of Short Plat 1794 to the Southeast corner of the said Lot also being the Northeast corner of Lot 4 of Short Plat 886 thence South along the East line of the said Short Plat 4 to the Southeast corner of the said Lot and a point on the North line of section 13 Township 24 N Range 17 E thence West along the North line of Section 13 to the Northeast corner of Lot 1 of boundary adjustment #2399 thence South along the East line of the said Lot 1 to the North line of Lot 2 of Short Plat 3099 thence East along the North line of the said Lot 2 to the Northeast corner of the said Lot 2 thence South along the East lines of Lot 2 of Short Plat 3099, Lot 3 of Short Plat 1903 and lot 4 of Short Plat 578 to the Southeast corner of the said Lot 4 and the Northeast corner of the Southwest quarter of the Northeast quarter of the said Section 13 thence West along the north line of the said Southwest quarter of the Northeast quarter of Section 13 to Northeast quarter corner of the North 209 feet of the West 209 feet of the said Southwest quarter of the Northeast quarter of Section 13 thence South 209 feet to the Southeast corner of the said parcel thence West 209 feet to the Southwest corner of the said parcel and the center line East Leavenworth County Road thence Southerly, Southwesterly and Westerly along said center line of East Leavenworth County Road to the North South center section line of Section 23 Township 24 N Range 17 E thence South along the center Section line to the center quarter corner of the said Section 23 and the Point of Beginning and the end of this description.

BE IT HEREBY FURTHER RESOLVED that the Board of County Commissioners finds that the public necessity or welfare of the proposed territory and of its inhabitants requires the formation of said district, and also finds that the petition sufficiently complies with the provisions of Chapter 17.28 RCW; and

BE IT HEREBY FURTHER RESOLVED that a special election shall be conducted by the Chelan County Auditor within the boundaries of the proposed district on Tuesday, November 5, 2002. Absentee ballots will be mailed by the Auditor's office to the registered voters within the proposed boundaries twenty (20) days prior to the election; ballots may be deposited at a poll site or in the Auditor's office between 7:00 a.m. and 8:00 p.m. on election day, and

BE IT HEREBY FURTHER RESOLVED that this notice of special election shall also be published at least once a week for three consecutive weeks in a newspaper of general circulation in the county; and

BE IT HEREBY FURTHER RESOLVED that the ballot for said special election shall be in the following form:

"Shall a mosquito control district be established for the area described in Resolution No 2002-_____ adopted by the Board of Chelan County Commissioners on September ___, 2002"

BE IT HEREBY FURTHER RESOLVED that at the same special election there shall be submitted to the voters residing within the district, for their approval or rejection, a proposition authorizing the mosquito control district, if formed, to levy at the earliest time permitted by law on all taxable property located within the mosquito control district a general tax, for one year, of up to 25¢ per \$1,000.00 of assessed value in excess of any constitutional and statutory limitation for the authorized purposes of a mosquito control district. The proposition shall be expressed on the ballot in substantially the following form:

"One year 25¢ per \$1,000.00 of assessed value levy."

"Shall the mosquito control district, if formed, levy a general tax of 25¢ per \$1,000.00 of assessed value for one year upon all the taxable property within said district in excess of the constitutional and/or statutory tax limits for authorized purposes of the district?"

The proposition to be effective must be approved by a majority of at least three/fifths (3/5ths) of the persons voting on the proposition to levy such tax in the manner set forth in Article VII, Section 2(a) of the Constitution of this State, as amended by Amendment 59 and as thereafter amended.
