**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
LAKE FOREST PARK, WASHINGTON SUPPORTING THE  
DECISION TO RESCIND RESOLUTION 1079 RATIFYING THE  
MAYOR'S DECEMBER 3, 2007 EMERGENCY PROCLAMATION**

**WHEREAS**, the Emergency Services Director reported to the Mayor of the City of Lake Forest Park on December 3, 2007, that the city was experiencing a significant storm event causing flooding of residences, businesses, roadways, culverts and bridges, and that closures and evacuations could result in areas due to excess flood waters; and,

**WHEREAS**, the Mayor of the City of Lake Forest Park issued a proclamation declaring a local emergency on December 3, 2007 invoking the emergency powers of Title 38.52.070 Revised Code of Washington.

**WHEREAS**, that the Emergency Proclamation issued by the Mayor on December 3, 2007 was ratified by the City Council of the City of Lake Forest Park through Resolution 1079 that was adopted on January 10, 2008.

**NOW, THEREFORE**, the City Council of the City of Lake Forest Park, Washington, hereby resolves:

To rescind the Emergency Proclamation issued by the Mayor on December 3, 2007 and ratified by the City Council of the City of Lake Forest Park by Resolution 1079 adopted on January 10, 2008.
