NOW THEREFORE, BE IT RESOLVED, by this Clark County Board of Commissioners that "East County Fire and Rescue" is hereby approved as the new name for the consolidated Fire Districts #1 and #9.

A RESOLUTION REQUESTING THE BOARD OF COUNTY COMMISSIONERS TO RENAME CLARK COUNTY FIRE DISTRICT #9 TO "EAST COUNTY FIRE AND RESCUE".

WHEREAS, Fire District #9 seeks to change its legal name to "East County Fire and Rescue"; and

WHEREAS, RCW 52.30.060 grants the Board of County Commissioners the power to make that change; and



WHEREAS, Fire District #1 merged into Fire District #9 (on May 16, 2006) and Voters were told that the new Agency would be called "East County Fire and Rescue";

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Clark County Fire District #9, as follows:

The Board of Fire Commissioners of Clark County Fire District #9 formally asks the Board of Clark County Commissioners to rename the Fire District "East County Fire and Rescue".

ADOPTED at a meeting of the Board of Commissioners for Clark County Fire District #9 this 18th day of July 2006, the following Commissioners being present and voting.




