

ORDINANCE NO. 32-03

AN ORDINANCE of the City of Richland relating to and creating the Uptown Business Improvement District Fund.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RICHLAND AS FOLLOWS:

Section 1.01. Chapter 3.24 of the Richland Municipal Code, as last amended by Ordinance No. 39-02, is hereby amended by adding Section 3.24.671, Section 3.24.672 and Section 3.24.673 to read as follows:

3.24.671 Uptown Business Improvement District Fund-Created.

There is hereby created a fund, known and designated as the Uptown Business Improvement District Fund (UBID), into which shall be paid all UBID revenues from special assessments levied under the authority of RCW 35.87A, gifts and donations for the UBID fund, monies for expenditures made and reimbursements due to the UBID fund, and interest and all other income from the investment of deposits according to established City procedures and policies.

3.24.672 Uptown Business Improvement District Fund-Distributions.

On the first regular business day of each month, the finance manager is authorized, empowered and directed to distribute from the UBID Fund to the UBID the total amount of special assessments collected under RCW 35.87A.130 and Richland Ordinance No. 29-03 during the preceding month.

3.24.673 Uptown Business Improvement District Fund-Administration.

The finance manager shall keep a full and careful record of receipts and distributions with respect to the Uptown Business Improvement District Fund.

Section 1.02. This ordinance shall take effect the day following the date of its publication in the official newspaper of the City.
