9 RELATING TO WATER POLLUTION CONTROL, AMENDING SCC 7.53.140

10
11 WHEREAS, the Washington State Department of Ecology issued a National
12 Pollutant Discharge Elimination System (NPDES) Phase 1 municipal stormwater permit
13 to Snohomish County on January 17, 2007; and

14
15 WHEREAS, Ordinance No. 08-091, amending chapter 7.53 SCC consistent with
16 the NPDES Phase 1 municipal stormwater permit, was adopted by the Snohomish
17 County Council on July 30, 2008; and

18
19 WHEREAS, an incorrect reference to the Snohomish County Drainage Manual in
20 SCC 7.53.140 was identified after adoption of Ordinance No. 08-091; and

21
22 WHEREAS, SCC 7.53.140 subsections (1) and (2) should refer to Volume 5,
23 Chapter 4 of the Snohomish County Drainage Manual rather than Volume 5, Chapter 3
24 of the Snohomish County Drainage Manual;

26 NOW, THEREFORE, BE IT ORDAINED:

28 **Section 1.** Snohomish County Code Section 7.53.140, last amended by Ordinance No.
29 08-091 on July 30, 2008, is amended to read:

31 **7.53.140 Inspection, maintenance and repair of drainage facilities not owned by**
32 **Snohomish County.**

33
34 (1) Any owner or operator of a drainage facility of the types described in Volume
35 5, Chapter ((3))4 of the Snohomish County Drainage Manual must inspect the drainage
36 facility in accordance with the inspection procedures set forth in that chapter once
37 before February 15, 2012, and once every five years thereafter.

38 (2) If conditions in a drainage facility indicate that maintenance or repair is
39 needed based on Volume 5, Chapter ((3))4 of the Snohomish County Drainage Manual,
40 the owner or operator shall perform the maintenance and repair actions described in
41 that chapter in accordance with the schedule set forth therein.

42 (3) Inspection and maintenance records shall be retained for a minimum of five
43 years, and shall be made available to Snohomish County upon request.
